Formalities

- Length of 15-20 pages (without cover sheet, table of contents, and appendix, if applicable)
- DIN-A-4 format
 - o If the report is submitted in paper form, it must be stapled no loose paper collection)
 - Written on one side and not handwritten!
- Page margins: The standard setting for test processing is okay, but 2.5 cm at the top, 2.5 cm on the left, 3 cm on the right, and 3 at the bottom is better. Ensure that everything is still legible after binding and that there is a correction margin.
- Respectable fonts, e.g., Times New Roman, Arial, Garamond, or Calibri
- Font size 11–12 points, line spacing 1.5 (For larger fonts such as Arial, a smaller font size 11 points should be selected, for smaller fonts such as Times 12 points)
- Font size footnote 10 point, line spacing 1.2
- Headings should be set off visually and numbered sensibly
- Justification is recommended for the text parts.
- Continuous page numbering
- The cover page and table of contents do not have a page number
- Uniform and clear formatting
- Correct spelling, grammar, and punctuation

Structure

Cover sheet

The cover sheet should contain the following information:

- 1. University
- 2. Institute
- 3. Study program
- 4. Name of the module in which the report is written
- 5. Semester
- 6. Title



- 7. Name of the author, address, e-mail address, matriculation number
- 8. Submission date

Table of contents

- The table of contents gets its own page
- All chapter headings must be included
- The chapter headings in the table of contents must be identical to the headings in the thesis.
- The page number on which the corresponding chapter begins must be given for each heading.

Content components

The main text of the research report should have a minimum of 15 pages and should not exceed 20 pages, including the following eight elements:

1 Abstract

Max. 1 page

- Summary of the thesis
- Describe (the relevance of) the topic
- What is the research question?
- How is it tackled and answered? On which basis (material)? Include theories and methods
- What is your core argument?
- Relevant results

2 Introduction

- Introduce topic, your research interest, and its relevance
- Insights into the state-of-the art: Where is the gap in the existing literature?
- Formulation of the problem/research question
- Briefly elaborate about the chosen theoretical framework: To which theories do you refer?
- Briefly introduce material and methods
- In general: Reveal the structure of the thesis

3 State-of-the-Art

- Present a literature review on your topic/field. Which are the relevant and current works on which you build your work?
- To which theories do you refer? How do they connect to your work?

4 Material and Methods

- Description and classification of the sources (Own survey/data material? Field research? Quantitative/Qualitative methods? Secondary analyses? Meta analysis?)
- Which procedure did you use? (Please refer to literature)
- What is the basis of your analysis? How did you collect and generate the data material? Which methods of analysis were employed?

5 Research Experience/Critical Reflection

- Briefly describe the procedure of your research process
- How did you find access to the field?
- Which obstacles were you facing?
- Where/when/why did you have to change plans?
- In which ways was it necessary to adjust the original research idea accordingly to the social realities faced in the field?
- Reflect on your own role as a researcher/your position in the field



6 Main Results

- Core findings and central argument
- Original findings: reconnect to the state-of-the-art
- Main insights: reconnect to your theoretical framework. Which of your initial assumptions are (not?) confirmed, which concepts/theories can be further developed or re-defined, on the basis of your findings?

7 Conclusion

- Summary of the thesis
- Strictly summarize, please: this is not the place for new arguments or thoughts that had not been elaborated in the sections 2–6

8 Bibliography

- Formally correct list all the titles you have referred to and cited in your work
- In alphabetical order
